

# Fruit and Vegetable Incentives Program for Low-Income Families, 5583

One of the most significant predictors of health is nutrition. In our state, over 900,000 people face food insecurity, many of whom live in the 45<sup>th</sup> district.

Given that fruits and vegetables are more expensive than processed food, families on food assistance program are not as likely to purchase fresh options because they need their benefits to stretch longer.

SB 5583 creates a program which would encourage more consumption of fresh fruit and vegetables by giving matching funds to beneficiaries, so they buy more healthy foods. This will make a huge difference for families that cannot afford to buy fresh produce otherwise.

We produce enough food in this state to feed us all, and must do more to give our neighbors access to healthy food sources.

# Affordable Care Act Protections, 5805

Before the implementation of the ACA, it was common for people to be denied health coverage because of a pre-existing condition. SB 5805 would guarantee citizens of Washington that their health coverage is protected in the state, regardless of what happens at the federal level.

There have been many attempts to get rid of the ACA on the national level, and we need to assure Washingtonians that they won't be denied coverage due to an illness.

#### Long-term Care Trust, 5331

A growing crisis that our state is facing revolves around how we provide adequate long-term care for our seniors. Most of us don't feel prepared to meet the rising cost of long-term care for ourselves, let alone for other family members. I, myself have a healthy, vibrant 94 year old grandmother. The Long-Term Care Trust Act would set up a new benefit that allows people to contribute a little bit throughout their working decades and will provide up to \$36,500 in lifetime benefits.

Families would get to decide how to spend their benefit, which could pay for in-home care, nursing home care, and other approved long-term care services and supports like respite, a wheelchair ramp, Meals On Wheels or rides to the doctor.

### Adult Family Homes, 5672

Adult family homes are cost-effective and a critical component for providing care for our seniors. Our state's current Medicaid rates are too low for adult family homes to take individuals with developmental disabilities and dementia.

These seniors are some of the most vulnerable and often end up in hospitals instead of getting the care they need. Legislators sponsor the pages, who assist with the Legislature's work by making deliveries and performing other necessary tasks.

Pages spend a portion of each day attending Page School, which provides an opportunity to learn about the role of the Legislature, its process and its participants. The Legislature employs a certificated teacher with experience teaching civics and social studies, along with an assistant teacher. They bring a wealth of knowledge, experience, and enthusiasm to the Page School program.

For the Monday-through-Friday work week that they serve, pages are paid \$35 a day. Pages do not work overtime or on weekends, regardless of the Senate's work schedule.

Requirements to be a Senate Page are as follows:

- 1. Parent/Guardian permission is needed;
- 2. School's permission/recommendation;
- 3. Senate sponsor;
- Social Security card (student must bring with you the week you serve); and
- 5. Must be at least 14 years of age and not have reached your 17<sup>th</sup> birthday
